 appraiser and external is better she can put feelers out for possible names in consultation
 with Andrea and the board if required. A new Performance Agreement would need to be
 set to start in February if this option is to be utilised. Andrea has done this with Graeme for
 the past two years.
 - Monique is to email Rebecca Keating for a board questionnaire that she has used in the
 past to possibly assist with goal setting from aboard perspective. This is just an option if the
 board would like to use this. Andrea will have goals she will no doubt like to work on.
 - Rona Wheeldon to seek to understand and look at what the appraisal options are to the board before moving forward. PLG groups are the requirement going forward. This was a workshop at the conference in Christchurch.
 - Andrea is in a PLG group with three other Principals across Tauranga which has an Independent advisor from Core Education Briar Stewart.
 - Andrea has set goals going forward as a chance to revisit TPPS mission, vision and learner profile, are they still relevant and how do we see our children leaving TPPS?
 Maybe need to shape it all. Rebranding of TPPS? Community/Iwi consultation is needed.
